Information regarding "Provisional named list of successful candidates, subject to Approval of Competitive Acts by University Administrative Offices"

The Committee reminds that:

(A) Pursuant to the Notice of Competition as in https://dottorati.uniroma2.it/40th-cycle-p10244.aspx the positions available for the XL PhD Cycle in Mathematics are as follows:

BORSISTA ATENEO= UNIVERSITY SCHOLARSHIP – 5 positions **DIPENDENTE PUBBLICO= PUBLIC EMPLOYEE** – 2 positions **ESONERATO = NO SCHOLARSHIP** – 1 position

where, as from the web site https://dottorati.uniroma2.it/40th-cycle p10244.aspx

BORSISTA ATENEO= UNIVERSITY SCHOLARSHIP = Positions with MUR-funded scholarships where MUR = Italian Ministry of University and Research

DIPENDENTE PUBBLICO= PUBLIC EMPLOYEE = Positions with no scholarship reserved for public employees. This reservation of places is provided for in the current regulations on PhDs. You do not need to have an agreement between the university and your institution, you only need to be a public employee

ESONERATO = **NO SCHOLARSHIP** = Positions with no scholarship

- (B) The rules imposed by the University Administrative Offices to which the Committee is subject regarding the disclosure of the results of the evaluations are as follows:
- "The Committe shall transmit the provisional successfull list, subject to the outcome of the Administrative reviews, to those directly concerned in the following manner: [keep only the relevant indication]
- (1) by posting outside the examination venue the provisional named list of successful candidates or
- (2) by transmitting by electronic mail the provisional named list of successful candidates or
- (3) by posting outside the examination venue the provisional named list of successful candidates and also transmitting the same list by electronic mail.

The details of the evaluation of individual candidates may NOT be made public on any institutional website of the University until the Acts are approved. It will be possible to disclose only the provisional named list of successfull candidates as long as the term "provisional subject to Approval of the Competition Acts" is clearly stated.

The ranking list approved by the administrative offices and including the scores of the examinations, qualifications and position awarded will be published on the website of the Doctoral School."

- (C) Pursuant to the rules imposed by the Administrative Offices in (B), the Commitee has chosen to follow the mode of transmission (B)-(2), although this brings additional efforts to the already considerable activities of the Commitee related to the Competition, by transmitting via e-mail to the interested parties the "PROVISIONAL NOMINATING SUCCESSFUL LIST SUBJECT TO APPROVAL OF COMPETITION ACTS" without details on the evaluation of individual candidates (because these details are still subject to the Approval of Competition Acts by Central Administrative Offices) accompanied by the type of vacancies as in (A) for which each candidate in the list expressed intention to compete.
